Hold Harmless and Release of Liability

The undersigned hereby acknowledges and voluntarily agrees to release and hold *Breezy Valley Ranch, it's owners, employees and agents*, and any and all other persons, firms or corporations associated therewith, fully harmless from any accident, injury, illness, claim or damage (personal or property), to the undersigned or his/her horse, equipment or other property whatsoever which may result from the undersigned participating or engaging in any riding or related equine activities occurring on or off the premises of *Breezy Valley Ranch*, located at 36274 State Route 20 Hwy, Sedro Woolley, Skagit County Washington State, including but not limited to the BVRs riding areas, parking areas, driveways, barns and pastures.

The undersigned acknowledges and agrees that:

1. Riding or related equestrian activities may be dangerous and agrees to fully assume all risk, chance, hazard and responsibility associated with any riding or equestrian activities conducted on or off the *Breezy Valley Ranch* premises.
2. Riding or related equestrian activities may be dangerous and that he/she has had an opportunity to inspect *Breezy Valley Ranch* riding areas and agrees to release *Breezy Valley Ranch* owners of any and all liability.
3. *Breezy Valley Ranch and its owners, employees or agents* are not responsible for any lost or missing tack or personal belongings.
4. I further voluntarily agree and warrant to Release and Hold Harmless BVR and owners any liability whatsoever, including, but not limited to, any incident caused by or related to negligence, accidents, relating to injuries known, unknown, or otherwise not herein disclosed; including, but not limited to, injuries, death or property damage from: mounting; riding; dismounting; walking; riding; grooming; feeding; use of horse barn, paddock, trails or horse arenas, in any capacity; falling off horse whether horse is bucking, flipping, spooked, bolted or due to yourself loosing balance or if the horse was beyond your expertise and experience level etc.

Our insurance company has recommended that we obtain certificates of proof of equine liability coverage from anyone who hauls in to ride. If you have this insurance, please provide a copy with this packet. If you do not have equine liability coverage, be advised that should, for example, your horse hurt you, another horse or other person, cause property damage etc for any reason, you are responsible for and accepting that liability personally.

The undersigned acknowledges that he/she has read the entire Hold Harmless and Release of Liability and understands and agrees to be bound thereby. The undersigned further acknowledges that he/she is over the age of 18 years, OR that he/she is the authorized parent or guardian of the minor child.

If emergency medical care is required for myself and if I, or an accompanying spouse or relative, am not able to convey permission in a timely manner, then the undersigned authorizes appropriate emergency medical care as deemed necessary by emergency medical personnel, a physician or the medical facility providing treatment.

Notice to Parents and Guardians:

In many situations, a minor child cannot receive emergency medical attention without the authorization of a parent or guardian. If you are not going to be personally present at Breezy Valley Ranch, you should consider using this form in conjunction with your child's activities at Breezy Valley Ranch. You should arrange for a responsible person accompanying your child to have this form available if required.

Release for Minor Rider:

If emergency medical care is required for my child and if permission is not available in a timely manner, then the undersigned authorizes appropriate emergency medical care as deemed necessary by emergency medical personnel, a physician, or the medical facility providing treatment.

Riding Helmet Waiver

I, the undersigned, recognize the dangers inherent with horseback riding. I am assuming the hazard of this risk upon myself since I wish to ride horses. I realize I am subject to injury from this activity and that no form of preplanning can remove all of the danger that I am exposing myself too. I have been offered the advice of wearing a helmet, which could prevent permanent brain damage in the event of an accident. Against the advice of the BVR owner and their insurance company, if I don't wear a helmet, I am refusing this critical safety precaution. R.C. W. 4.24.53, 54, 55.

Anyone under the age of 18 must wear a helmet.

Haul in Rules

- Anyone under the age of 18 must have constant adult supervision.
- No access to the pastures, round pen, barns or stalls unless you have BVR permission.
- Anyone under the age of 18 must wear a helmet. Everyone is advised to wear a helmet.
- Boots with a heel are required for riding unless you are riding bareback.
- No dogs allowed.
- No alcohol, drugs, guns of any type at BVR.
- Please be mindful of your language in mixed company.
- Smoking is not allowed except in designated areas. If you smoke, I'll show you where that's at.
- Turn off the lights inside the arena or/and the bathroom after you're done.
- **Nobody rides or handles a horse at BVR unless a Haul in packet has been signed.**
- If the arena is in use and you are hand walking your horse, please stay to the inside or mutually agree on who will be working their horse where. Be courteous.
- When tying your horse, always use one of the tie rings. Please don't tie to the rails or gates.
- If you need to do fence work with your horse, there are two specific areas in the arena where this is ok and it's sturdy enough to handle shifting weight. Please don't climb on any of the other gates on hinges.
- No snapping of the lunge whip or waving of a flag unless the other party said it is ok (if someone else is in there with you).
- You are responsible for your own equipment, please take your equipment with you when you leave. Putting your name on it is recommended so there are no mixups.
- Nothing is to be hung or posted in the arena stall or anywhere else on the property unless approved.
- Hosting a lesson or horse training program for money out of BVR's arena is prohibited. Helping others is fine if both parties are in agreement. Please be respectful, everyone does thing differently.
- Clean up all loose hay, shavings and manure by your trailer before leaving.
- Any manure your horse eliminates in the arena, please pick it up and put in the wheelbarrow provided or take it with you if we forgot to put the wheelbarrow out.
- Payment is expected in the designated area prior to departing BVR for the day.
- The arena doors must be left as you found them. We get strong winds through here. If they are latched closed, you can open them while you are using the arena but you must latch them closed and make sure everything is secure when you leave.
- You may use the equipment in the arena, please put anything you used back where you found it.
- Fee for arena use is \$10 for each horse hauled in.
- There is no limit on your time during haul in as long as it's within the designated haul in hours currently posted.
